Assignment Title: Consultancy Services for Site 1: Design and Supervision for Reconstruction and Repairs to Waterloo #3 Road, and Site 2: Design Review and Supervision for Reconstruction and Repairs to Jennings Mountain Road and River Fords

The Government of Saint Vincent and the Grenadines (GoSVG) has received financing from the World Bank toward the cost of the Volcanic Eruption Emergency Project (VEEP) and intends to apply part of the proceeds for consulting services.

The Consulting Services (“the Services”) include the following:

1. Site 1: Design & Supervision for Reconstruction and Repairs to Waterloo #3 Road
2. Site 2: Design review & Supervision for Reconstruction and Repairs to Jennings Mountain Road and River Fords

The duration of this consultancy is estimated to be 60 weeks followed by a 12-month construction Defects Liability Period. The Terms of Reference (TOR) for the assignment is located on the government website (www.gov.vc) via the following link:

The Ministry of Finance, Economic Planning and Information Technology (MoFEP) now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:

1. Experience with the design of roadways in mountainous, tropical marine climates
2. Experience with the application of Transport Research Laboratory (TRL) standards for tropical countries
3. Experience with construction and QA/QC supervision and project management
4. Experience with the preparation of environmental analysis and management plans

Key experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III - Governance, paragraphs, 3.14, 3.16, and 3.17 of the World Bank’s “Procurement Regulations for IPF Borrowers” 4th

Edition November 2020 (“Procurement Regulations”), setting forth the World Bank’s policy on conflict of interest. In addition, consultants shall refer to the requirements on conflict of interest related to this assignment as per paragraph 3.17 of the Procurement Regulations.

Consultants may associate with other firms in the form of a joint venture or a subconsultancy to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Least Cost-based Selection (LCS) method set out in the Consultant Guidelines.
