The Government of Saint Vincent and the Grenadines (GoSVG) has received financing from the World Bank toward the cost of the Volcanic Eruption Emergency Project (VEEP) and intends to apply part of the proceeds toward payments under the contract for procurement of **Purchase of Equipment for the Ministry of Agriculture, Forestry, Fisheries, Rural Transformation, Industry and Labour.**

The document will be sent via email to the interested Suppliers if requested.

Bids will be publicly opened in the presence of the Supplier's designated representatives and anyone who chooses to attend at the address below on **August 22nd 2023 at 2:30pm (Local Time)**.
