The Government of Saint Vincent and the Grenadines has received financing from the World Bank toward the cost of the Volcanic Eruption Emergency Project (VEEP) and intends to apply part of the proceeds toward payments under the contract for the **Supply of one Climate Controlled Greenhouse for the Ministry of Agriculture, Forestry, Fisheries, Rural Transformation, Industry and Labour.**
2. The Economic Planning Division of the Ministry of Finance, Economic Planning and Information Technology now invites sealed Bids from eligible Bidders for **Supply of one Climate Controlled Greenhouse for the Ministry of Agriculture, Forestry, Fisheries, Rural Transformation, Industry and Labour.** The delivery period is expected to be one hundred and twenty (120) days from contract effectiveness. Bidders are required to have the following minimum qualifications:
  - i. Audited financial statements for the last three (3) years;
  - ii. Demonstrate having successfully completed one (1) similar contract within the last five (5) years of a value of at least USD 250,000.00;
  - iii. Be eligible to supply goods under the contract;
  - iv. Demonstrate authorisation as a dealer or distributor of the offered goods or provide a Manufacturer's Authorization.
3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "**Procurement Regulations for IPF Borrowers**" **Fourth Edition November 2020** ("Procurement Regulations") and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from **Economic Planning Division in the Ministry of Finance, Economic Planning, and Information Technology** and inspect

the bidding document during office hours *09:00 to 16:00 hours (9:00am to 4:00pm SVG time)* at the address given below.

5. The bidding document in **English** may be requested by interested Bidders upon the submission of a written application (by email, fax, hand delivered) to the address below. The document will be sent via email to the interested Bidders.
6. Bids must be delivered to the address below on or before 14:00 hours (**2:00pm SVG time**) **December 29<sup>th</sup>, 2023**. Electronic Bidding **will be permitted**. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **December 29<sup>th</sup>, 2023** at 14:15 hours (**2:15pm SVG time**).
